WAIVER

ALL PARTICIPANTS in the Animal Rescue League of Iowa Inc. (ARL) Iowa Dog Jog ARE REQUIRED TO ASSUME ALL RISK OF PARTICIPATION IN THE ARL's Iowa Dog Jog Event (hereinafter referred to as "event" or "ARL's Iowa Dog Jog" or "Dog Jog") BY SIGNING THIS RELEASE AND WAIVER OF LIABILITY AGREEMENT: The undersigned Participant (Participant) and on behalf of Participant's personal representatives, assigns, heirs, and executors, fully and forever releases from all liability, including negligence, the Animal Rescue League of Iowa, Inc., and all city and/or municipal agencies whose property or personnel are used, including Terra Park and the City of Johnston, all other sponsoring or co-sponsoring companies or individuals related to the Events, and their respective employees, agents, volunteers, representatives and affiliates (collectively the Releasees). Participant and on behalf of Participant's personal representatives, assigns, heirs and executors waives the right to sue Releasees for all losses and damages that arise from any injury to Participant or Participant's property or resulting in Participant's death in connection with the Participant's participation in the Event including but not limited to losses or damage caused by the negligence of all or any of the Releasees, the negligence of others, weather conditions or otherwise, and also including any pre or post-race activities and any programs and/or giveaways conducted at the events and/or activities by a sponsor or other third party. The Participant warrants that Participant is in good physical condition and is able to safely participate in the Event. The Participant is fully aware of the risks and hazards inherent in participating in the Event, including the possibility of serious physical trauma, injury or death, and elects to voluntarily compete in the Event knowing such risks. The Participant agrees to the use of Participant's name and photographs in broadcasts, newspapers, magazines, brochures, and other media without compensation. The Participant acknowledges that the entry fee is nonrefundable and non-transferable. The Participant acknowledges that Rip Roar Events LLC has the right to alter, change, cancel and/or postpone any of these events as a result of circumstances that would affect or impact the event which are beyond their control. The Participant warrants that all statements made in this release agreement are true and correct and understands that Releasees have relied on them in allowing Participant to participate in the Events. PARTICIPANT HAS READ THE FOREGOING, UNDERSTANDS ITS CONTENTS AND INTENTIONALLY AND VOLUNTARILY CERTIFIES COMPLIANCE BY ACCEPTING THIS WAIVER. I hereby consent to receive or for the PARTICIPANT named to receive medical treatment which may be deemed advisable in the event of injury, accident or illness during the ARL's Iowa Dog Jog event. No warranty as to the quality of medical care is to be made. I hereby acknowledge that I have sole responsibility for the below listed participant's personal possessions and equipment during the ARL's Iowa Dog Jog event, and its related activities. I hereby permit and authorize the free use and publishing of my or the PARTICIPANT'S name, image and picture and videos in websites, broadcasts, telecasts and the press as they pertain to the ARL's Iowa Dog Jog, the race sponsors, event photographers, and city entities. I hereby absolve and hold harmless all and any parties or entities associated with the ARL's Iowa Dog Jog from any damage I or the PARTICIPANT may sustain because of any breach of these representations.

Photos will be taken by Converging Photography and other media and I hereby release those photos to be used by Converging Photography, RipRoar Events and the Animal Rescue League of Iowa.
